- Homicides: 69 (down 1% from 2024)
- Sexual Assault: 38 (down 50% from 2024)
- Robberies: 628 (down 23% from 2024)



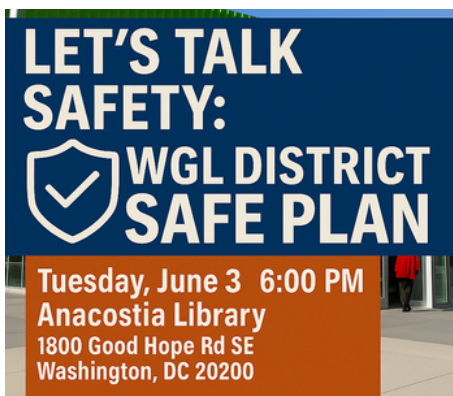


## Q2 LOOK AHEAD

WGL's SAFE Plan outlines a three-year effort to upgrade its distribution system by replacing 12 miles of gas main and addressing approximately 4,132 service lines—including replacements, remediations, and transfers—at an estimated total cost of \$215 million.
